Minutes KSU Staff Senate Meeting (remotely via Teams) February 15, 2021

Call to Order:

February meeting of the Kennesaw State University Staff Senate via Microsoft Teams on February 15, 2021. David Easterwood, Staff Senate president, called the meeting to order at 10:00a.m. Agenda approved at 10:02am and minutes from January meeting approved at 10:04am. Treasurer's Report, Bonnie Acton: Invoice was paid last month, balance should be reduced accordingly, scholarship account was increased. Dec. amount was 1413.00, following the February fundraiser we should have around \$200 in donations. Scholarship balance should exceed \$1500.

Guest Speakers:

Donna Reddix, Director, Office of Institutional Equity, Non-Discriminatory Policy: No changes to the existing policy. The policy will now be uploaded to the portal, is incorporated with the university policy and is in accordance with federal law. The only difference is that now it is available via university policy portal. Q: Where do we report any discriminatory hiring practices? Kevin Gwaltney Ph.D., Director of Policy, Office of Accreditation and Policy, Univ. Policies: On policy portal, all that are in review or coming soon are noted as in progress. Committee Updates:

Bylaws: Nothing specific about online meetings so is that something policy and procedures needs to look into or the creation of that language in bylaws?

Policy and Procedures: Potentially moving representation from 3 to 4 years of service. Possibility of making officers non-voting members and allowing them an extra year of service. Also looking into announcing and keep information up online, especially in light of special meeting that just took place. This change is office representation might curb the conflict of interest in procedures.

Q: Faculty Senate is discussing a motion to provost and president about no-layoffs. Do we want to add any notes to that? Q: Where did the layoffs come from if we are seeing record enrollment? A: Budget can be two-three years behind. We also have to look at drop offs from Fall to Spring as enrollment is posted. (Please add this to response to the resolution). Originally a \$10 million budget cut with furlough days was implemented. Some of the position cuts kept furlough days from happening in conjunction from funds sent down for COVID to keep salaries paid during teleworking. Now federal funding is no longer in place so some of the layoffs are having to occur. Q: What is the purpose we are serving? A: We are supposed to serve as a conduit between staff and administration. The purpose is overarching issues for staff as a whole and helping get individual problems to the right place. Q: Are there any ways we can get together or provide a time for the group to get to know each other and spend time outside of discussing business? meeting adjourned at 11:06am.
